1. WHAT INFORMATION DO WE COLLECT?

Some personal data is provided to us by you and we receive some personal data from third parties, for example through technology such as cookies. We collect personal information, or "personal data," to manage our mailing list and newsletter. Personal data" is the information that identifies you as an individual. For example, your name or contact information. You may choose not to provide us certain personal data; however, you may be unable to use certain functionalities of our website. Information Collected Automatically. To improve our website, products and services, we collect and use aggregated information which does not personally identify you. When you visit our website, we may automatically receive your computer's internet protocol (IP) address, your operating system and browser type, device type, the web pages you visit on our website, the address of any referring website, and your geographic location. This information is also used to operate, maintain, and manage our website. For example, we may calculate the average number of site visitors who visit a particular webpage on our website.

2. THIRD PARTY LINKS ON OUR WEBSITE

Our website may contain links to other third party websites for your convenience. We are not responsible for the privacy policies and practices of other third parties and any information you submit to a third party is subject to their privacy policy. Once you leave the Santana Tesoro website or are redirected to a third-party website, application, or other online service, we encourage you to read the privacy policy applicable to that third party.

Please note that Santana Tesoro is only responsible for managing the Santana mailing list and newsletter associated with Santana.com. Our affiliate High Fidelity Entertainment ("HiFi") facilitates merchandise sales though store.santana.com and our affiliate Official Community manages the Fan Club at fanclub.santana.com. Once you leave the Santana Tesoro webpage where this Privacy Notice is posted, we encourage you to read the privacy policy applicable to the third party service or website you are accessing.

3. HOW DO WE USE THE INFORMATION WE COLLECT?

We use the personal data we collect to communicate with you and to provide the services you have requested. We also use the data we collect to operate our business, improve our services and to send you marketing offers that we think may interest you.

TO PROVIDE AND IMPROVE OUR SERVICES

We use personal data to provide our services and facilitate communication between you, Santana Tesoro and other third party service providers when you join our mailing list to receive our newsletter. We may also use personal data to understand how our customers use our website in order to enhance our site.

TO COMMUNICATE WITH YOU

4. WHY DO WE SHARE THE INFORMATION WE COLLECT?

We share personal data with our affiliates, vendors and third party service providers as described in this notice to process on our behalf or to complete a transaction you have requested. We also share personal data if required by law, to protect our customers or others, to maintain security, or to operate our business. We will not sell or rent your personal data to third parties without your permission.

THIRD PARTY SERVICE PROVIDERS

We may share your personal data with third parties such as other Santana Tesoro affiliates or vendors to perform services on our behalf, such as to provide technical services, or to facilitating marketing activities and other promotions.

SOCIAL MEDIA

Your personal data may be disclosed in connection with your social media activity. If you connect or otherwise choose to engage with Santana Tesoro on social media, the social media site may collect your personal data or may share information with us about your use of its services. Information you choose to share in a social media post may also be disclosed to any third party capable of viewing that post. BUSINESS USE

If we are involved in a merger, acquisition, sale, or other change in ownership, personal data may be among the transferred business assets.

5. COOKIES & OTHER SIMILAR TECHNOLOGIES

Like many other websites, we use cookies and other similar technologies to improve the performance of our website. Our website may also include web beacons and cookies from third party service providers. Cookies are small text files sent from a website and stored on your browser while you visit a website. Cookies track how you use a website and enable the website to remember your preferences and settings and help us analyze how our website is performing.

Many web browsers are set up to accept cookies automatically, but you may change your cookie preferences through the options available in your web browser. Please review the options available in the web browser that you are using to make changes to your cookie preferences. You may choose not to receive certain cookies, however please note this may affect the availability of certain features of our website.

Session Cookies provide information about how a website is used during a single browser session while a user is visiting a website and usually expire after the browser is closed.

Persistent Cookies remain on your device between different browser sessions for a set amount of time in order to enable the website to remember user preferences, settings, or actions across other sites.

First-Party Cookies are cookies set by the website you are visiting. They have the same domain or subdomain as what is in your browser's address bar.

Third-Party Cookies are set by third parties that are different from the website you are visiting. These cookies have a different domain or subdomain than what is in your browser's address bar.

ANALYTICS

We use third party analytics services to understand how our website is accessed and used to improve the performance of our website and to send marketing information that may we think may interest you. For example, we use **Google Analytics** which uses cookies and other similar technologies to collect and analyze information about how our website is used.
